

# In Memoriam

#### ROBERT H. HYDRICK, MD

Dr. Robert Hydrick passed away on Tuesday January 24, 2023. He graduated from the University of South Carolina and Vanderbilt University School of Medicine, becoming the third generation of physicians in his family, following in the footsteps of his father and grandfather.

Dr. Hydrick did his internship and residency in OB/GYN at Butterworth Hospital. He received a commission in the Medical Corps of the Michigan National Guard, rank of Major, and remained active in the National Guard through 1958. Dr. Hydrick practiced OB/GYN for nearly 50 years in Grand Rapids and was proud to deliver over 6,000 babies and provide comprehensive healthservices to women.

#### **CARLETON A. SMITH, JR., MD**

Dr. Carleton Smith passed away on December 20, 2022. Born October 13, 1950, Chip grew up in Bloomfield Hills, Michigan. He followed in his father's footsteps and went to medical school at Wayne State University training in emergency medicine. He moved to North Carolina for residency in anesthesia at Duke University. Chip's love for the outdoors brought him to Albuquerque, New Mexico where he practiced anesthesiology and raised a family. He then moved to Grand Rapids, Michigan, where Chip practiced medicine until his retirement.

#### RICHARD L. KREUZER, MD

Dr. Richard Kreuzer passed away on Tuesday, November 15, 2022. Richard enlisted in the U.S. Air Force after high school and trained in Washington, D.C., as a German linguist. He was stationed in Hof an der Saale, Germany, where he served enjoyably formative years as part of

the 6915th Security Group. After returning stateside, he attended Calvin College, and then medical school at the University of Michigan. He did his residency in Grand Rapids and ran a solo practice in obstetrics and gynecology in the area. Richard had also furthered his military career by earning his Flight Surgeon wings, and he remained active in the Michigan Air National Guard until he retired with the rank of Lt. Col.

#### JAMES D. WEBB, MD

Dr. James Webb passed away on November 26, 2022. He graduated from Wheaton College and Wayne State University School of Medicine. Jim interned at Butterworth Hospital for one year before serving for three years in the US Army in Germany. He did a five-year general surgery residency at Butterworth before going into private practice in Fremont beginning in 1977. Throughout his life, Jim made many trips to Africa and Haiti to work in mission hospitals. He was also an active board member of Bethesda Mission and Grace Ministries International.

#### EARL R. WILLIAMS, MD

Dr. Earl Richard Williams passed away on January 5, 2023. Upon graduation from Grand Haven High School Earl was accepted into the United States Naval Air Cadet training program in Pensacola, Fla, earned his Naval wings, and was thereafter commissioned a 2nd lieutenant Marine Aviator in the United States Marine Corps. His Marine Corps service was primarily in Iwakuni Japan flying A-1 (AD) Skyraiders. After honorable discharge from the Marine Corps, Earl attended Ferris State University before beginning his formal medical education at Wayne State University School of Medicine and practicing as an obstetrician.

#### 120TH KCMS ANNUAL MEETING

### **MSMS** President **Updates Members**



At the 120th Annual Meeting of the KCMS. Thomas Veverka, MD, President of MSMS and Past President of Saginaw County Medical Society, presented an update to KCMS Members on projects of the MSMS Board.

#### **Highlights**

- The MSMS Task Force to Advance Health Equity. chaired by Theodore Jones, MD, is meeting monthly. Most recently, the Task Force assisted in the creation of a physician survey to access awareness of racial and ethnic health disparities; and further determine what tools are needed by physicians so they may address racial and ethnic health disparities in their practices.
- MSMS received a planning grant from the W.K. Kellogg Foundation allowing MSMS to host regional summits from March through May. A summit will be held in Kalamazoo at the Radisson Plaza Hotel Tuesday, May 2, 2023 at 2:30-3:30pm.
- · Senate committee assignments have been identified and MSMS is working on lobbying with the new legislature. Kevin Hertel (Southeast Michigan) is chairing Senate Health Policy, and Sylvia Santana (Southeast Michigan) is chairing the DHHS budget.
- · Now that Medicaid eligibility redetermination is decoupled from the end of the public health emergency, members could see eligibility changes for their Medicaid patients very soon.
- · Members who were not able to attend the virtual State of MSMS Address with Thomas M. George, MD, Interim CEO on January 11, can access a recording of the presentation here.
- The MSMS House of Delegates will be held on April 22-23, 2023, at The Henry, Autograph Collection, in Dearborn. Members interested in serving on the County Delegation should contact the KCMS office.

# Legislative Update

Governor Gretchen Whitmer delivered her fifth State of the State address in late January, marking the first speech in the Michigan Capitol since the start of the pandemic. The speech carried a bi-partisan tone, urging lawmakers to work across the aisle to deliver on issues.

#### **Policy Priorities**

The Governor outlined the following policy priorities during the address:

- **Education investment** 
  - Including free pre-K and a focus on individualized tutoring options for all students.
- **Targeted tax cuts**

Including ending the tax on retiree public pensions and boosting the Earned Income Tax Credit.

- **Gun safety** 
  - Including universal background checks, red flag, and safe storage laws.
- **Expansion of Elliot-Larson Civil Rights Act** To include LGBTQ persons.
- Repeal of the 1931 abortion ban

#### Senate Bill 7

The House and Senate approved an appropriations supplemental bill. Senate Bill 7 included \$146.3 million to close the books for fiscal year 2021-22 and then added another \$946.2 million in new spending for current fiscal year 2022-23.

The bill contains funds for several projects in fiscal year 2022-23, including:

- \$200 million for an economic development project in the Escanaba region.
- \$150 million for affordable housing and housing gap financing.
- \$150 million for a deposit into the Strategic Outreach and Attraction Reserve (SOAR) fund.

- \$100 million for community revitalization and placemaking grants.
- \$25 million for blight elimination,
- \$75 million for small business smart zones.
- \$33 million in infrastructure grants.

The Independent Citizens Redistricting Commission also will receive \$3.2 million under the bill to cover additional legal costs. The appropriations for fiscal year 2021-22 included \$120 million in federal funds for the Department of Health and Human Services Food Assistance Program.

Did you know, in 2022, there were 112 messages from Kent County physicians to elected officials? These were sent by physicians practicing in emergency medicine, pediatrics, clinic settings, anesthesiology, dermatology, internal medicine, neurology, medical administrators and more.

Group practices, hospital systems and individual practice owners reached out to Governor Gretchen Whitmer, Lieutenant-Governor Garlin Gilchrist, Senators and Representatives representing Michigan to voice

concerns on Prior Authorization Reform, Increased Funding for Primary Care, Exemption of Federal CMS Guidelines, and more. Physicians also sent messages urging elected officials to move legislation and to support physicians to improve quality medical care for Michigan patients.

# Electronic-Prescribing Enforcement

Beginning January 1, 2023, Michigan physicians will be required to electronically transmit all prescriptions for controlled and non-controlled substances.

Since January 1, 2023, Michigan physicians have been required to electronically transmit all prescriptions for controlled and non-controlled substances.

Michigan's statute allows for a waiver to be issued if a prescriber cannot meet the electronic prescribing requirements. The form and instructions for applying for the waiver are posted on the BPL website.

In addition to the waiver, Michigan's statute provides the following exceptions to the e-prescribing mandate:

- If the prescription is issued by a prescriber who is a veterinarian licensed under this article.
- If the prescription is issued under a circumstance in which electronic transmission is not available due to a temporary technological or electrical failure.
- If the prescription is issued by a prescriber who has received a waiver from the department under subsection (7).
- If the prescription is issued by a prescriber who
  reasonably believes that electronically transmitting
  the prescription would make it impractical for the
  patient who is the subject of the prescription to
  obtain the prescription drug in a timely manner and
  that the delay would adversely affect the patient's
  medical condition. A prescriber who does not
  electronically transmit a prescription under this
  subdivision shall document the specific reason for
  his or her belief that the delay would adversely affect
  the patient's medical condition.
- If the prescription is orally prescribed under section 7333(3) or (4).
- If the prescription is issued by a prescriber to be dispensed outside of this state.
- If the prescription is issued by a prescriber who is located outside of this state to be dispensed by a pharmacy located inside of this state.
- If the prescription is issued and dispensed in the same health care facility and the individual for whom

the prescription is issued uses the drug exclusively in the health care facility. As used in this subdivision, "health care facility" includes, but is not limited to, any of the following:

- A hospital.
- A hospice.
- A dialysis treatment clinic.
- A freestanding surgical outpatient facility.
- A skilled nursing facility.
- A long-term care facility that provides rehabilitative, restorative, or ongoing skilled nursing care to an individual who is in need of assistance with activities of daily living.
- If the prescription contains content that is not supported by the National Council for Prescription Drug Programs Prescriber/Pharmacist Interface S CRIPT Standard.
- If the prescription is for a drug for which the FDA requires the prescription to contain content that cannot be transmitted electronically.
- If the prescription is issued under circumstances in which the prescriber is not required to include on the prescription a name of a patient for whom the prescription is issued including, but not limited to, a prescription issued under section 5110.
- If the prescription is issued by a prescriber who is prescribing the drug under a research protocol.
- If the prescription is dispensed by a dispensing prescriber.
- If the prescription is for a dialysis-related drug that is administered as part of or incident to a home-based dialysis treatment.

# Current Trends of the Opioid Epidemic in Kent County

While the United States was experiencing the greatest pandemic in modern history, the opioid epidemic continued to impact the lives of residents. Through a variety of factors such as an increasingly potent drug supply, disruption in resource access, and interrupted social networks, the number of opioid-involved overdose deaths in the United States increased by 60% from 2019 to 2021.

#### **RACIAL DISPARITIES**




FIGURE 2 Three-Year Average Opioid-Involved Overdose Death Rate by Race (Kent County, 2012-2021)

Although Kent County did not experience an increase in opioid-involved overdose deaths between 2019 and 2021 [Figure 1], the aggregate count of deaths hides a significant increase in how the epidemic has impacted black residents. The three-year average opioid overdose death rate among blacks in Kent County increased 57% between the years 2018-2020 and 2019-2021, while the rate among whites did not change [Figure 2]. While the reason for the difference in overdose death rates cannot be fully elucidated, racial minorities with substance use disorders often experience more stigma, criminalization, and barriers to accessing to evidence-based treatments.2

#### SUBSTANCE TRENDS





FIGURE 3 Percent of Opioid-Involved Deaths with Select Substances Present (Kent County, 2015-2021)

Fentanyl contamination in the drug supply remains prevalent and is now involved in 90% of opioidinvolved overdose deaths, compared to less than 20% in 2015 [Figure 3]. Fentanyl has also been identified in 86% of overdose deaths involving methamphetamine and 66% involving cocaine.

Xylazine, a non-opioid veterinary tranquilizer, has become increasingly prevalent in the drug supply in the United States.3 Its effects include skin ulcers and abscesses, and it can increase the risk of an overdose through respiratory depression. Xylazine has been identified in forensic toxicology re-ports in Kent County, although its prevalence is unknown.

FIGURE 1 Number of Opioid-Involved Overdose Deaths (Kent County, 2012-2021)

#### **COMMUNITY UPDATES**

The Grand Rapids Red Project received funding from the Michigan Department of Health and Hu-man Services to purchase naloxone vending machines for several locations in Kent County: Kent County Health Department (700 Fuller Ave NE, Grand Rapids); Cherry Health (100 Cherry St SE, Grand Rapids); Grand Rapids Red Project (401 Hall St SE, Grand Rapids). These outdoor vending ma-chines stock the intranasal form of naloxone, Narcan<sup>®</sup>, as well as fentanyl test strips.

Kent County recently convened an Overdose Fatality Review (OFR), a multidisciplinary group of stakeholders tasked with reviewing individual overdose fatalities to identify opportunities to prevent similar events from occurring in the future. The OFR has been meeting monthly since September 2022. During each meeting, the group discusses two to three opioid overdose fatalities, utilizing records from health systems, law enforcement, treatment, and social services.

Through assessing various aspects of a person's life, the OFR can piece together a detailed tapestry of how our systems work together and how they could work even more effectively. Recommendations from the OFR range from the individual level, such as increasing access to medication for opioid use disorder, to the systemic level, such as improving coordination among multiple systems to improve patient support and follow-up. Depending on the type, recommendations may be provided to organizations directly or they may be referred to the Kent County Opioid Task Force.

#### **GUIDANCE FOR PHYSICIANS AND HEALTHCARE PROFESSIONALS**

Prescribing medications for opioid use disorder (MOUD) is one of the most effective strategies for treating opioid use disorder.4 There are many resources available to providers who are interested in prescribing MOUD, such as the Michigan Opioid Collaborative.5 Referrals can also be made to local centers that provide treatment for opioid use disorder. A list of specialty clinics in the Grand Rapids area that prescribe medications for opioid use disorder can be found on the Kent County Health Department's website.
